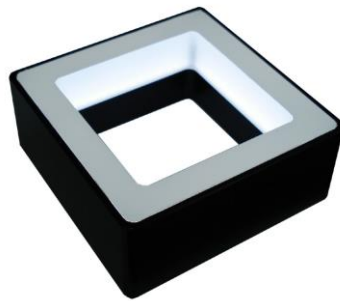


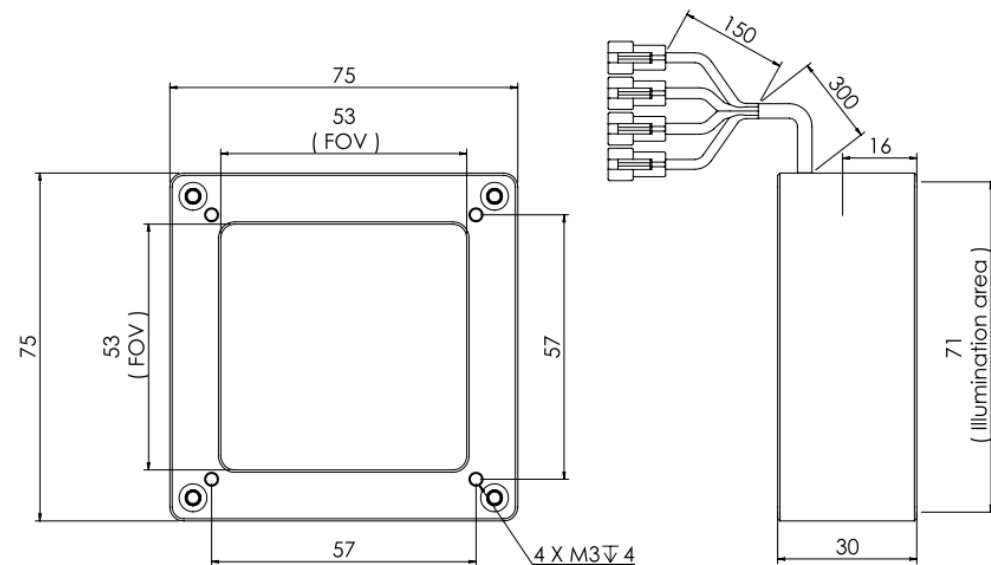
Low Angle Square Diffuse Light
